How to choose the sample size  $n$ ?

## Two questions for determining sample size

- 1 How narrow do we want confidence intervals to be? ←
- 2 What level of confidence do we want to have?  $\alpha = ?$



$$\bar{X}_n \pm z_{d/2} \frac{\sigma}{\sqrt{n}} \quad \leftarrow \text{Margin of error}$$

$$\bar{X}_n \pm t_{n-1, d/2} \frac{s_n}{\sqrt{n}} \quad \text{or, for large } n \quad \bar{X}_n \pm z_{d/2} \frac{s_n}{\sqrt{n}} \quad \rightarrow$$

**Recall:** Our CIs for a mean and a proportion were of the form

$$\bar{X}_n \pm \text{ME} \quad \text{and} \quad \hat{p}_n \pm \text{ME},$$

where ME was the *margin of error*.

**Strategy:** Choose  $n$  large enough to make ME as small as desired.

$$\hat{p}_n \pm z_{d/2} \sqrt{\frac{\hat{p}_n(1-\hat{p}_n)}{n}} \quad \leftarrow \text{Margin of error}$$

Consider bulky C.I. for  $\mu$  as

$$\bar{X}_n + \underbrace{z_{d/2} \frac{\sigma}{\sqrt{n}}}_{\text{M.E.}}$$

Require  $z_{d/2} \frac{\sigma}{\sqrt{n}} \leq M \leftarrow$  desired maximum margin of error.

$$\Leftrightarrow z_{d/2} \frac{\sigma}{M} \leq \sqrt{n}$$

$$\Leftrightarrow z_{d/2}^2 \frac{\sigma^2}{M^2} \leq n$$

$$\left( z_{d/2} \frac{\sigma}{M} \right)^2 \leq n$$

$t_{n-1, d/2}$  inconvenient

For large  $n$ , an approximate  $(1 - \alpha) \times 100\%$  CI for  $\mu$  is

$$\bar{X}_n \pm \underbrace{z_{\alpha/2} \frac{\sigma}{\sqrt{n}}}_{\text{ME}}$$

### Sample size for estimating $\mu$

For a maximum desired margin of error  $M$  and confidence level  $1 - \alpha$ , take

$$n = \left\lceil \left( \frac{z_{\alpha/2} \cdot \sigma}{M} \right)^2 \right\rceil.$$

In the above,  $\lceil x \rceil$  is the smallest integer greater than or equal to  $x$  (“round up”).

The unknown  $\sigma$  can be replaced by an estimate from a previous or pilot study.

**Exercise:** Derive the sample size formula.

**Exercise:** Researchers wish to estimate the mean gestation period of tortoises with the margin of error at the 95% confidence level no greater than 0.5 months.

Previous studies have estimated the standard deviation of gestation periods to be roughly 2 months. What sample size should be used?

$$\alpha = 0.05$$

assume  $\sigma = 2$

$$M = \frac{1}{2} \leftarrow \text{desired M.E.}$$

Need  $n \geq \left( z_{\alpha/2} \frac{\sigma}{M} \right)^2 = \left( z_{0.025} \frac{2}{1/2} \right)^2 = \left( 1.96 \frac{2}{1/2} \right)^2 = 61.97.$

Take  $n = 61$

Build  $(1-\alpha)^{100\%}$  C.I. for  $\phi$  as

$$\hat{p}_n \pm z_{\alpha/2} \sqrt{\frac{\hat{p}_n(1-\hat{p}_n)}{n}}$$

M.F.

I want

$$z_{\alpha/2} \sqrt{\frac{p_n(1-\hat{p}_n)}{n}} \leq M$$

Put some "p" in place of  $\hat{p}_n$  (since we have not yet observed  $\hat{p}_n$ ).

$$z_{\alpha/2} \sqrt{\frac{p(1-p)}{n}} \leq M$$

$$\Leftrightarrow z_{\alpha/2} \frac{\sqrt{p(1-p)}}{M} \leq \sqrt{n}$$

$$\Leftrightarrow \left( z_{\alpha/2} \frac{\sqrt{p(1-p)}}{M} \right)^2 \leq n$$

For large  $n$ , an approximate  $(1 - \alpha) \times 100\%$  CI for  $p$  is

$$\hat{p}_n \pm \underbrace{z_{\alpha/2} \sqrt{\frac{\hat{p}_n(1 - \hat{p}_n)}{n}}}_{\text{ME}}$$

$p \in (0, 1)$

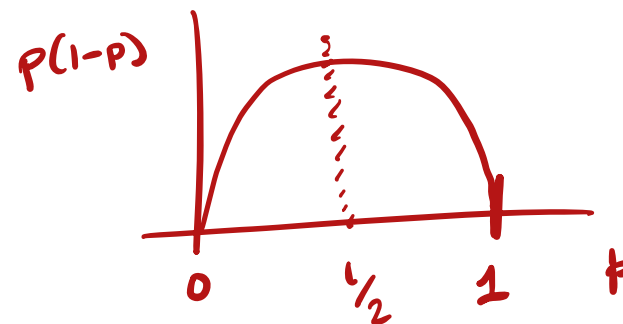
## Sample size for estimating $p$

For a maximum desired margin of error  $M$  and confidence level  $1 - \alpha$ , take

$$n = \left\lceil \left( z_{\alpha/2} \cdot \frac{\sqrt{p(1-p)}}{M} \right)^2 \right\rceil.$$

The unknown  $p$  can be replaced by

- 1 an estimate from a previous or pilot study
- 2 or simply by  $p = 1/2$  (results in largest  $n$ ).



**Exercise:** Derive the sample size formula.

$$n = \left\lceil \left( z_{\alpha/2} \frac{\sqrt{p(1-p)}}{M} \right)^2 \right\rceil$$

**Exercise:** We wish to estimate with 99% confidence the proportion of voters who will vote for a particular candidate with a ME no greater than 2 percentage points. What sample size do we need?

$$\alpha = \underline{0.01}$$

$$M = 0.02$$

$$p = \frac{1}{2}$$

$$n = \left\lceil \left( z_{0.005} \frac{\sqrt{\frac{1}{2}(1-\frac{1}{2})}}{0.02} \right)^2 \right\rceil$$

2.5758 (from t-table)

$$= \left\lceil 4146.7 \right\rceil$$

$$= 4147$$

At  $\alpha = 0.05$ ,  $n = 2901$  is sufficient.
